The significance of nodes

The node concept is where governance, policy and architecture meet

The procurement of the EOSC-EU- Node and the upcoming 2024 funding call labeled "Future Engagement Model for the EOSC Federation (2024)" are an opportunities for the community to focus on how we want to organise the EOSC platform



meosc Types of resources offered by EOSC Nodes

- FAIR data a fundamental goal of EOSC is to build a "web of FAIR data", therefore nodes should provide FAIR data through one or more trustworthy data repositories.
 - The data repository must be recognised as belonging to a local, regional, national, or international community of scientific activity.
 - It must have the right to distribute and share data through a documented data policy adhering to the FAIR principles.
 - Trust and sustainability of the data repository must be ensured and ideally certified through a certification process e.g. CoreTrustSeal or similar.
- Services a node does not necessarily have to provide data but instead can provide services for processing and/or storing FAIR data.
 - The node must provide access to the services under a documented policy which defines the rules of usage.
 - The services must be recognised to be of general interest to a wider community and possibly be open to all EOSC users.
- A substantial number of the EOSC Nodes will most likely provide both FAIR data and services.

specific restauration investment for EOSC Nodes

- Visibility EOSC Nodes will gain wider visibility for their data and services, offered through EOSC's
 portals and search capabilities, encouraging secondary re-use of data, increased impact for data and
 service providers.,
- Cross domain cross domain research will be fostered by joining the EOSC Federation, as well as
 exploitation of research outcomes by industry and the public sector by being part of the EU Data Spaces.
 The EOSC Federation will form a data space that will have direct linkage with multiple Common
 European Data Spaces now being deployed as part of the EU Strategy for Data.
- Common services joining the EOSC Federation will provide access to common federating services e.g.
 AAI, data transfer, monitoring, and accounting, etc.
- Training common training for data stewards and researchers
- **Financial support** making data and services available to a wider community has a cost for nodes. Joining the EOSC Federation may open the possibility for future financial support to address the additional costs incurred through increased usage of data and services. The exact form of this funding i.e. if it is funded through services or externally, will depend on the future funding of the EOSC and how the Federation evolves.

 rules of governance, value proposition and rules of participation
- Who driven by the EOSC-A and encouraging all interested parties (EC, Member states/ACs, RIs, EOSC-A members, etc.) who want to participate in the cocreation of the Handbook
- Process the document will be written collaboratively with open consultations, meetings, sprints

The development of EOSC is an evolving process which gets closer to a working implementation every year.

The most recent development in the architecture of EOSC is the concept of a federation of nodes implementing a system of system type architecture. The first node to be developed is the EOSC EU Node promoted and financed by the European Commission. The EOSC EU Node has been procured by the European Commission and will be hosted and implemented by 3rd party sub-contractors. The EOSC EU Node is planned to be released for testing in autumn 2024, but already has a web presence.

With the advent of the EOSC EU Node the next step is to identify the first set of EOSC Nodes to implement the Federation of Nodes










Relationship to EOSC-A


We are considering 70 responses, since we received 3 responses from the same Mandated Organisation, made by three different representatives.
